

# Gift Aid Declaration

## BOOST YOUR DONATION BY 25p OF GIFT AID FOR EVERY £1 YOU DONATE

As a Registered Charity (No. 1044099) we can benefit from the Gift Aid scheme, which enables us to increase the value of part or all of your donations, to the charity. If you pay UK Tax, please consider signing this declaration. It costs you nothing. Please remember that you don't necessarily have to be earning to participate in the scheme. If you receive a pension or you have some investments, then you will very likely be paying some tax and so will be eligible. By signing the declaration below, the government will top up your donations – providing Christian CARE Association with an extra 25p of Gift Aid for every £1 you donate, at no additional cost. Gift Aid is reclaimed by the charity from the tax you pay for the current tax year. Your address is needed to identify you as a current UK taxpayer.

  - I change my name, my home address or my contact details
  - I no longer pay sufficient tax on my UK income and/or Capital Gains Tax
